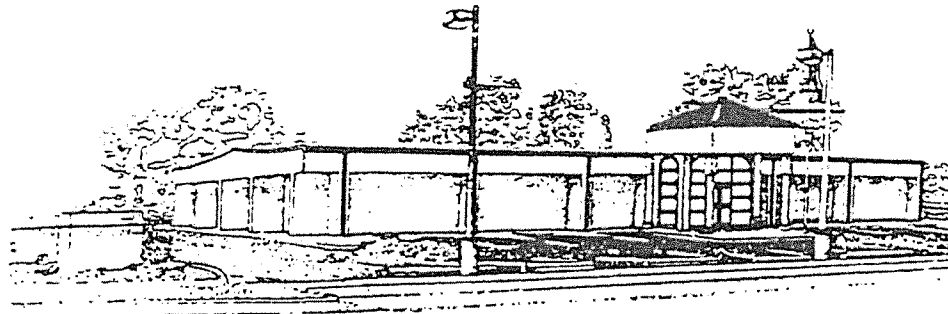

I will ensure that an assigned proof of compliance will always remain attached to the rear of the cart or UTV in plain sight. I furthermore ensure that I will obey all the rules and regulations set forth by the City of Hoopston concerning the operation of a golf cart or UTV within the City limits.*

### GOLF CART SELF INSPECTION ORDINANCE COMPLIANCE

Following is a list of what a golf cart is required to be equipped with in order to comply with the city golf cart ordinance. Indicate next to each requirement if your golf cart is in compliance.

- Brakes
- Steering apparatus
- Horn
- Tires
- Rearview Mirror
- Front and rear red reflectorized warning devices
- Slow moving emblem on rear of cart in conformity with 625 ILCS 5/12-709 of IL vehicle code
- Headlight that emits a white light visible from a distance of 500 feet to the front
- Tail lamp that emits a red light visible from at least 100 feet from the rear
- Brake lights
- Turn signals
- Seat belt for any or all rear facing seated passengers
