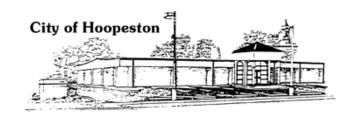

MINUTES FROM 8-6-24 CITY COUNCIL MEETING

SPECIAL COUNCIL MEETING

CITY OF HOOPESTON

TUESDAY, AUGUST 13, 2024

7:00 PM - CITY HALL

- I. CALL TO ORDER Mayor Wise called the meeting to order at 7:00 pm following the pledge of allegiance.
- II. ROLL CALL The following 4 alderpersons were present: K. Ferrell, M. Ferrell, Porth, and Scharlach. Mayor Wise and Clerk Hardcastle were also present. Attorney Miller was present on Zoom.
- III. AMENDMENT OR APPROVAL OF THE AGENDA Alderwoman K. Ferrell moved to approve the agenda as presented. Alderman Porth seconded the motion. Motion carried 4-0.
- IV. APPROVAL OF THE MINUTES FROM THE PREVIOUS COUNCIL MEETING Alderman M. Ferrell moved to approve the minutes of the previous council meeting. Alderwoman K. Ferrell seconded the motion. Motion carried 4-0.
- V. APPROVAL OF THE PAYMENT OF THE BILLS Alderwoman K. Ferrell moved to approve the payment of the city's bills. Alderman Porth seconded the motion. A roll call vote was taken (Ayes: K. Ferrell, M. Ferrell, Porth, Scharlach Nays: None Absent: Eyrich, Garrett, Lawson) and the bills were approved 4-0.

- VIII. PUBLIC COMMENT
 - a. Josh Clifton addressed the council and stated that it has been 89 days since the attack on his girlfriend. He is still requesting the city to hire a 3rd police officer to be on duty at all times. It is his opinion that the city council does not want to make tough choices and take a strong stance on crime. We have huge crime rates and businesses or people do not want to move in. Mr. Clifton went on to describe crime in Chicago. He has heard several alderpersons say that if they are not on a committee then there is nothing that they can do. Mr. Clifton stated that alderpersons oversee everything and if they do not think they have a voice then they should resign. If Robin Lawson is the chairman of the police committee, it does not matter, but they can find a way to hire more officers.

Alderman Scharlach advised that the fire department is working on a few things and he will report on them at the next meeting.

XIV. MAYOR COMMENTS

UNFINISHED BUSINESS – None

- a. HOTEL DEVELOPMENT Mayor Wise distributed the latest version of the hotel development agreement. There are several items in the agreement that will have to be filled out by the developer. There was lengthy discussion on the proposed roadway and the language governing the roadway and who has to pay for what. Attorney Miller advised that the language needs to read that the road will be built to the city's specifications and get approval from the city engineer. Mayor Wise then reviewed the other sections of the agreement. He then reviewed the financials of the agreement; the city would be putting in \$50,000 from the TIF fund, \$200,000 from the remaining City of Hoopeston ARPA funds, and \$600,000 from the Vermilion County ARPA funds. The ARPA money has to be allocated by the end of 2024 and spent by the end of 2025. Mayor Wise asked Attorney Miller to explain the escrow agent. Alderman M. Ferrell asked what the exact definition of road funds meant in the agreement. Mayor Wise read the definition listed in the agreement. Attorney Miller stated that we could flesh those definitions out more. Alderman Scharlach asked about highway access and if IDOT had funding available for that. Mayor Wise stated that it is up to the developer to fund the connection to the highway. Mayor Wise then stated that the agreement will be brought up at the next meeting.
- b. GOLF CART PATH Mayor Wise announced that the golf cart path on the west side of Kirby Foods is open. He thanked Kirby Foods for allowing the path to be placed there. He reminded residents that this is for golf carts only and has seen several cars on the path. Signs will be put up and other options are being considered to keep cars off of it.

XVI. ADJOURNMENT – There being no further business to come before the council, Alderwoman K. Ferrell moved to adjourn the meeting. Alderman M. Ferrell seconded the motion, and the meeting was adjourned.

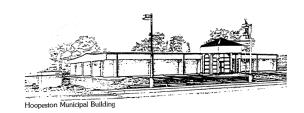

FEHR-GRAHAM ENGINEERING SERVICES AGREEMENT

RESOLUTION NUMBER 24 -

- A Resolution to accept an Engineering Service Agreement with Fehr Graham & Associates, LLC for Design and Bidding Phases of Wastewater Treatment Plant Improvements Project (IEPA Loan # L17-6587, 6588, and 6589), and to authorize Mayor to sign IEPA Loan Application Forms, and other Documents during the progress of the project
- WHEREAS, City Council of City of Hoopeston authorized Fehr Graham & Associates, LLC to prepare the Illinois Environmental Protection Agency (IEPA) required Phosphorus Removal Feasibility Study Report, and Total Phosphorus Discharge Optimization Plan for City's existing Wastewater Treatment Plant (WWTP) (FGA#22-060) in December 2021, that were prepared and submitted to IEPA as per requirements of Special Conditions 20 and 21 of City WWTP's current National Pollution Discharge Elimination System (NPDES) Permit (#IL0024830) in April 2022; and,
- WHEREAS, City Council of City of Hoopeston authorized Fehr Graham & Associates, LLC to prepare the IEPA-required Facility Planning Report (FGA#22-898) for improving City's WWTP facility to replace aging plant equipment and upgrade/modify the plant to add new Biological Nutrients Removal (Total Phosphorus and Total Nitrogen removal) Processes in July 2022, that was prepared and submitted to IEPA in March 2023; and,
- WHEREAS, the IEPA issued the pre-approval of the Facility Plan in the form of "Preliminary Environmental Impacts Determination (PEID)" on February 28, 2024, requiring the City to hold the public hearing, and allow post-hearing 10-day comment period, and,
- WHEREAS, City of Hoopeston held the IEPA-required PEID public hearing on April 2, 2024, at the Hoopeston City Hall, and allowed post-hearing 10-day public comment period, which ended on April 12, 2024; and PEID hearing summary documentation was submitted to IEPA on April 18, 2024, and,
- WHEREAS, the IEPA concurred and issued a formal approval of the Facility Plan under provisions of IEPA Water Pollution Control Loan Program as per 35 Illinois Administrative Code Part 365.330 on May 4, 2024; and,
- WHEREAS, City is required to advance the project through next steps of Design and Bidding completion in order for the City to keep the project in the annually issued IEPA Intended Funding List (IFL), obtain Letter of Commitment (LOC) with the project funding reserved at the end of design phase, and secure the formal IEPA loan agreements with the IEPA loan program offered incentives a low "Hardship" interest rate, additional environmental discount on top of low interest rate; and "principal forgiveness" for each IEPA loan, and,
- **WHEREAS,** City obtained the Engineering Services Agreement (ESA) from Fehr Graham & Associates, LLC for the Design and Bidding phases of this project (IEPA Loan

#L17-6587, 6588, 6589) with the corresponding amount budgeted in the Facility Plan approved by IEPA in May 2024; and,

WHEREAS, City Council of City of Hoopeston recommends the Approval of the Engineering Services Agreement with Fehr Graham & Associates, LLC for Design and Bidding phases of this project for the amount of \$1,941,000.
